#### **BACKGROUND OF NEW JSA BOARD NOMINEES:**

#### **Christina Meyer:**

Christina has been a member of Seawanhaka Corinthian Yacht Club since 1992 and the New York Yacht Club since 2001. She is currently the Junior Activities Chair at SCYC. During her tenure since 2018, Seawanhaka's Junior Club participation showed a substantial increase in membership driven by program initiatives and the implementation of a year round Optimist race team. Her initiatives included new marketing strategies within the yacht club environment, teaching environmental stewardship through an oyster gardening program, and establishing strong positive parent involvement. Christina has also served on the SCYC House Committee for 10 years and SCYC Race Committee for 12 years. She is married to Willets who served as SCYC Commodore from 2012-2018. She has four children (Willets 19, Hannah 16, Cole 13 & Gwen 13), all of whom are past or present JSA sailors. Christina's racing experience includes Sonars, NY40, Seabird and Sabre 38. She and her family currently own a J/44 "Beagle" that they enjoy racing as well as cruising. Christina is a graduate of St. Dominic High School in Oyster Bay, New York and received a BS in accounting from the University of Hartford in Connecticut.

#### Henriette Rohl:

Henriette is a member of Sea Cliff Yacht Club, where she has been actively involved in the Junior Sailing Program for six years. Primarily, she likes to advocate for kids and the environment. As chair of the Sea Cliff junior program for three years, she was instrumental in bringing five RS Fevas to the club, to expand sailing opportunities and engage sailors once they outgrow Optis. Additionally, she revisited hiring international instructors, and hosted several over the years. She started the first Annual Family Ideal 18 Regatta at the club, where kids plan and host a regatta to sail with their parents. Since 2019, she has been on the Western District Regatta committee. She is also actively involved with the Young American Sailing Academy, which promotes leadership skills through big boat offshore sailing. Her daughter, Annika, sails a Laser and crews on two J/105s whenever possible. Henriette has 25 years of experience in financial services, her last position as VP in business banking at major bank. She has run a small business for the last five years with her husband, Tom. She has served on various boards, both as a volunteer and as an elected Trustee for the Village of Sea Cliff.
